We believe that honesty is key to any healthy relationship. We understand that you are trusting us with information that is important to you, and we want to be open about how we use it.

Here we describe the privacy practices for our applications, software, website, APIs, products, and services (the “Services”). You will learn about the data we collect, how we use it, the controls we give you over your information, and the measures we take to keep it safe.

## INFORMATION WE COLLECT

When you use our Services, we collect the following types of information.

### INFORMATION YOU PROVIDE US

#### ACCOUNT INFORMATION

Some information is required to create an account on our Services, such as your nickname, email address, password, and in some cases your mobile telephone number. This is the only information you have to provide to create an account with us. You may also choose to provide other types of information, such as an image or emoji.

#### ADDITIONAL INFORMATION

To help improve your experience or enable certain features of the Services, you may choose to provide us with additional information, like your logs for food, weight, sleep, water, or female health tracking; an alarm; and messages on discussion boards or to your friends on the Services.

If you contact us or participate in a survey, contest, or promotion, we collect the information you submit such as your name, contact information, and message.

#### PAYMENT AND CARD INFORMATION

We do not collect any payments or card information. If a payment is made, it is made at the payment site. We do not store card information on our server or site.

#### INFORMATION WE RECEIVE FROM YOUR USE OF OUR SERVICES

##### DEVICE INFORMATION

We do not have access to your devices.

##### GEOLOCATION INFORMATION

We do not have access to your geolocation information.

##### USAGE INFORMATION

When you access or use our Services, we receive certain usage or network activity information. This includes information about your interaction with the Services, for example, when you view or search content, create or log into your account.

We do not collect data about the devices and computers you use to access the Services. We do not collect cookie information or metadata from your device.

#### INFORMATION WE RECEIVE FROM THIRD PARTIES

We do not receive information from third parties. We do not give share or sell information to thirds parties.

#### HOW WE USE INFORMATION

We use the information we collect for the following purposes.

#### **PROVIDE AND MAINTAIN THE SERVICES, PERIOD.**

Using the information collected, we only provide you with customer support and ways to improve our website.

#### **IMPROVE, PERSONALIZE, AND DEVELOP THE SERVICES**

We use the information we collect to improve and personalize the Services and to develop new ones. For example, we use the information to troubleshoot and protect against errors; perform data analysis and testing; conduct research and surveys; and develop new features and Services.

#### **COMMUNICATE WITH YOU**

We use your information when needed to send you Service notifications and respond to you when you contact us. You can control communications and most Service notifications by using your “Unsubscribe” link in an email.

#### **PROMOTE SAFETY AND SECURITY**

We use the information we collect to promote the safety and security of the Services, our users, and other parties. For example, we may use the information to authenticate users, protect against fraud and abuse, respond to a legal request or claim, conduct audits, and enforce our terms and policies.

We use cookies and similar technologies for the purposes described above.

#### **HOW INFORMATION IS SHARED**

We never give away, share or sell the personal information of our users. We do not share your personal information except in the limited circumstances described below.

## WHEN YOU AGREE OR DIRECT US TO SHARE

You may direct us to disclose your information to others, such as when you use our community features like the forums, and other social tools. Just remember that if you choose to share your information, information like your profile photo, posted messages, personal statistics, ect, this will be visible to anyone with a browser.

You may also direct us to share your information in other ways, for example, when you give a third-party application access to your account, or give your employer access to information when you choose to participate in an employee wellness program. Remember that their use of your information will be governed by their privacy policies and terms.

## FOR LEGAL REASONS TO PREVENT HARM

We may preserve or disclose information about you to comply with a law, regulation, legal process, or governmental request; to assert legal rights or defend against legal claims; or to prevent, detect, or investigate illegal activity, fraud, abuse, violations of our terms, or threats to the security of the Services or the physical safety of any person.

Please note: Our policy is to notify you of legal process seeking access to your information, such as search warrants, court orders, or subpoenas, unless we are prohibited by law from doing so. In cases where a court order specifies a non-disclosure period, we provide delayed notice after the expiration of the non-disclosure period. Exceptions to our notice policy include exigent or counterproductive circumstances, for example, when there is an emergency involving a danger of death or serious physical injury to a person.

We may share non-personal information that is aggregated or

de-identified so that it cannot reasonably be used to identify an individual. We may disclose such information publicly and to third parties, for example, in public reports about total challenges and activity, to partners under agreement with us, or as part of the community benchmarking information we provide to users of our subscription services.

If we are involved in a merger, acquisition, or sale of assets, we will continue to take measures to protect the confidentiality of personal information and *give affected users notice before* transferring any personal information to a new entity allowing you to close your account and delete your data.

## YOUR RIGHTS TO ACCESS AND CONTROL YOUR PERSONAL DATA

We give you settings to access and control your personal data, as described below, regardless of where you live. If you live in certain jurisdictions, you may have legal rights with respect to your information, which your settings allow you to exercise, as outlined below.

**Accessing and Exporting Data.** By logging into your account, you can access your personal information. You may download all your content in the export tools with owner login privilege. If you are unable to do this, contact [ouroffice@server1.network](mailto:ouroffice@server1.network) using your login email for assistance.

**Editing and Deleting Data.** By logging into your account and using your settings, you can change and delete your personal information. For instance, you can edit or delete the profile data you provide and delete your account if you wish. Once deleted, only archived copies are available and will not be handed over to anyone or authority without legal cause.

If you choose to delete your account, please note that while most of your information will be deleted within 3 days, we may also preserve data for legal reasons or to prevent harm, including as described in the [How Information Is Shared](#) section.

## **DATA RETENTION**

We keep your account information, like your name, email address, and password, for as long as your account is in existence because we need it to operate your account. In some cases, when you give us information for a feature of the Services, we delete the data after it is no longer needed for the feature. We keep other information, like your exercise or activity data, until you use your [account settings](#) or tools to delete the data or your account because we use this data to provide you with your personal statistics and other aspects of the Services. We also keep information about you and your use of the Services for as long as necessary for our legitimate business interests, for legal reasons, and to prevent harm, including as described in the [How We Use Information](#) and [How Information Is Shared](#) sections.

## **ANALYTICS AND ADVERTISING SERVICES PROVIDED BY OTHERS**

We do not work with partners who provide us with analytics and advertising services.

## OUR POLICIES FOR CHILDREN

We appreciate the importance of taking additional measures to protect children's privacy.

Persons under the age of 18, or any higher minimum age in the jurisdiction where that person resides, **are not permitted to create accounts**. If we learn that we have collected the personal information of a child under the relevant minimum age without parental consent, we will take steps to delete the information as soon as possible. ## INFORMATION SECURITY
